- 1. This application must be completed, signed, and submitted to the EAA prior to capping an Edwards Aquifer well.
- 2. The application must be typed or printed legibly using ink.

I. - General Information – Please provide **all** of the following:

- 3. A fee of \$125.00 must accompany the application. (\$25 application fee and \$100 administrative fee)
- 4. <u>Checks and money orders</u> made payable to the "Edwards Aquifer Authority" will be accepted. <u>Do not</u> submit cash. To pay by Credit Card, please open https://www.edwardsaquifer.org and click Online Payments and follow the instructions. **Please provide the payment Confirmation No.**
- 5. Upon receipt of a complete application, please allow thirty (30) days for processing.
- 6. Incomplete applications will be returned to the applicant for completion.
- 7. Well capping cannot commence until the application is approved and a well capping permit has been issued.
