EAA Education Outreach Center's Native Plant Demonstration Garden Receives Texan by Nature Certification

San Antonio, Texas – On Tuesday, September 12, 2023, The Edwards Aquifer Authority Education Outreach Center (EAA EOC) Native Plant Demonstration Garden received a Texan by Nature (TxN) Project Certification for its meaningful conservation efforts involving and benefitting people, prosperity, and natural resources. Founded in 2011 by former First Lady Laura Bush, TxN connects conservation to business, amplifying projects and activating new investments in conservation which return real benefits to people, prosperity, and natural resources of the state.

The EAA EOC Native Plant Demonstration Garden was created to introduce concepts of water conservation through the use of colorful native plants that are drought-tolerant. The demonstration garden relies solely on water that has been collected from the EOC's rainwater harvesting system, and uses a drip irrigation system to ensure the garden receives adequate water. Visitors are introduced to various water conservation methods that can be implemented in their backyards. By using these methods, the garden is able to conserve more water. This system also helps to save money, reducing the cost typically associated with continuously watering plants with conventional methods. The EAA collaborated with the San Antonio River Authority (SARA) to identify the best drought-tolerant, native plants and trees to plant in the garden.

"The Native Plant Demonstration Garden at the EOC serves as an educational resource for the community," said Sarah Valdez, EAA Senior STEAM Outreach Educator. "It offers opportunities for visitors to learn about the state's unique ecological heritage. Being part of Texan by Nature's Conservation Partner network connects us to 140+ organizations and initiatives across Texas dedicated to conservation and sustainability. This interconnectedness allows us to collaborate, share best practices and collectively make a more significant impact."

The EAA EOC Native Demonstration Garden is proud to be Texan by Nature Certified, and continues to be a sight to see for EAA EOC visitors eager to learn about different drought tolerant and Texas native plants they can grow in their yards.
