



## Notice of Intent to Finish a Crop

Submit this Notice of Intent to Finish a Crop (NIFC) form no later than December 1 if the critical period reductions have or will cause you to exceed your reduced authorized amount for a crop planted this year.

Additionally, persons exercising their right to finish out a crop may not plant an additional crop in the same calendar year unless the additional crop is dry land farmed or the person irrigates from a source other than the Edwards Aquifer. If a person plants an additional crop after the NIFC form is approved by staff, this form will be deemed to be withdrawn and the person will be required to reapply for NIFC protection or maintain compliance with the applicable permitted groundwater withdrawal amounts as adjusted by critical period reductions. **Please note, if the place of use that is the subject of the application does not have water rights associated with it at the time the application is filed, it will be deemed incomplete, and staff will cease processing it. Applicants will need to reapply by or before December 1 once water rights are acquired.** All Notices filed may be subject to site inspections during CPM.
