

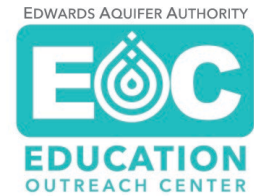

EAA Education Outreach Center Only Place in San Antonio to View Endangered Texas Blind Salamander

San Antonio, Texas - The EAA Education Outreach Center (EAA EOC), which is open to the public and free of charge, marks the next generation of water education for the communities the EAA serves. The Center recently welcomed its first endangered Texas Blind Salamander, which is featured in a special aquarium and on display for people to see up close – the only place San Antonio that offers a rare look at this species for free! The Texas blind salamander is an endangered species of aquatic salamander that is found only within the Edwards Aquifer in Central Texas. This species is *troglobitic*, or cave dwelling, which has resulted in it being both blind and eyeless. These lungless salamanders breathe through their gills and are characterized by their lack of eyes, external red gills, slender limbs, a broad head, transparent-pale color, and grow to about 4-5 inches as adults. The Texas Blind Salamander joins another endangered species, the Fountain Darter, to be on display at the EAA EOC.

Since 1996 The Edwards Aquifer Authority has successfully implemented a landmark permitting system for regulating withdrawals from the aquifer and is administering the Edwards Aquifer Habitat Conservation Plan (EAHCP), ensuring protection of threatened and endangered species reliant on waters from the aquifer. "The EOC's newest endangered species aquaria exhibit that house the endangered Texas Blind Salamander and Fountain Darters are great educational tools for the center to teach the community and students about the mission of the EAHCP. The addition of the ArcGIS *StoryMaps*

touch screen provides supplementary interactive and engaging information on all the Edwards Aquifer threatened and endangered species protected by the EAHCP," states Scott Stornment, EAA Executive Director for Threatened and Endangered Species.

The Education Outreach Center is also hosting a "Name that Texas Blind Salamander" contest for the public to help it name its newest endangered salamander. Authority, City of San Marcos, City of New Braunfels, Texas State University, and the City of San Antonio acting by and through the San Antonio Water System (collectively known as the EAHCP Permittees) to protect federally listed species from specific activities, Covered Activities, like groundwater pumping.
